Also, a retrospect of road traffic crash trends from mid-year 2012 till June 2015 has been incorporated for better evaluation.







## PUBLIC ENLIGHTENMENT ACTIVITIES (JANUARY-JUNE, 2015)















## 2015 Half year Total RTC trend on States Basis





## 2015 Half year fatal cases trend on States Basis




### 2015 Half year trend of Number of Persons Injured on States Basis







### MID-YEAR EVALUATION OF THE 2015 GOAL



Improved Stakeholders' Consultation and Road Use Education.

Full utilization of the Corps digitalization platform/System.

Improve the Corps Legal framework and Regulatory Capacity.

Improved Enforcement, rescue and advisory capacity of the Corps.

Reduce RTC by 20%

Reduce Fatality by 30%

In every month of the year 2015, and every quarter spent, Speed and Speed related crashes have been identified as the most probable cause of road fatality so far. Dangerous Driving and Loss of Control have contributed to most crashes.

There are positive improvements on all parameters of road traffic crashes (RTCs, Fatalities) in 2015 over 2014 as well as in Q2 over Q1, 2015.

The trend of law enforcements has been almost stagnant and barely ondulating especially after the General Elections in March, 2015

Approximately 7.7 million people and 1.2 million vehicles travelled per month in Nigeria as observed from January to June, 2015. However, 3,921,201 vehicles transited Nigerian roads in February, 2015 thus becoming the highest recorded figure so far. This, without ambiguity is connected with the general election anxiety that lingered for a while.

The Corps is on track towards meeting its 2015 Goals with respect to RTC and Fatality as 15.1% and 12.4% reductions in Fatality and RTC respectively have been achieved over 2014 records.

States in the North Central region of the country including the FCT , Oyo and Ogun have prominently featured on States in the country with highest RTCs, Fatal cases, Number of persons killed and injured thus requiring special intervention patrols



The Corps' to focus, prioritize and mobilize resources towards organizing at least three(3) intervention Patrols in the metropolis and major highways leading into and out of the identified States prominently featured with higher crash index.

The Corps as a matter of imperative, re-energize its zeal as it was in the beginning of the year to achieve the 2015 goal as well as meet the mandate of Accra declaration 2007.

The implementation of the Speed Limiter Installation policy should be given maximum attention to curb and curtail speed related crashes nationwide

The Corps to speedy implement the Safe-To Load programme for Hydrocardbon products conveyance by tankers to forestall the incidences recorded in recent times.

The Corps' operations activity to be more funded for improved law enforcement nationwide as road audit and research is recommended to unravel new blackspots and proffer necessary advice.
