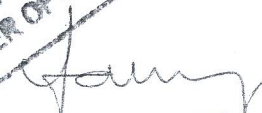
1. The Name of the company is **FEDERAL ROAD SAFETY CORPS POST SERVICE SCHEME LTD/GTE**
2. The Registered Office of the Company will be situated in Nigeria
3. The Objects for which the Company is established are:
 - a) To promote the construction and maintenance of Post Housing Estate at a subsidized rate for serving and retired officers propose and facilitate development of Post-Housing Estate or officers and to provide some dwelling units on such Estate to interest civilians at commercial rates to engage in and compliment efforts in solving problems faced by officers in securing hoses after retirement from service.
 - b) To engage in building construction and maintenance service of every description, including planning, design, erection, improvement, repairs, alteration, maintenance and demolition of construction works.
 - c) To provide technical and administrative assistance to officers who opt to acquire housing through sources other than the company.
 - d) To cater for the welfare of retired corps member.
 - e) To empower the members and entire staff financially.
 - f) To organize seminars, symposiums and workshops in all areas of Federal Road Safety Corps Post Service Scheme geared towards and the enhancement, development and advancement of Post-Housing Estate in Nigeria.
 - g) To advance the performance of Federal Road Safety Corps Post Service Scheme with the latest knowledge, methodologies, strategies and effective solutions to Post-Housing Estate challenges.
 - h) To give award to deserving individuals, professionals, institutions whether public or private in Nigeria for the development, enhancement and advancement of Post-Housing Estate.
 - i) To do all such other things as may be considered to be incidental or conducive to the attainment of the above objects or any of them.
4. The Company is a Private Limited Company.
5. The liability of the members is limited by Guarantee.



6. The income of the property of the company shall be applied solely towards the promotion of the objects of the company as set forth in this Memorandum of Association and no portion thereof shall be paid or transferred directly or indirectly by way of dividend, bonus or otherwise however by way of profit to the members of the company. However, nothing herein shall prevent the payment, in good faith of remuneration to any servant of the company or to any other person, for services actually rendered
7. Every member of the company undertake to contribute to the assets of the company in the event of the same being wound up where he is a member, or within one year after he ceases to be a member, and of the costs, charges and expenses of winding up and for the adjustment of the rights of the contributories among themselves, such amount as may be required to be contributed by all members shall not be less than **N10,000.00**
8. If upon the winding up or dissolution of the company there remains after the satisfaction of all its debts and liabilities any property of the company, the same shall not be paid or distributed among the members of the company but shall be given or transferred among some other companies having companies shall be determined by the members prior to the dissolution of the company.
