HISTORICAL ANTECEDENTS OF PSS

Over the years, the FRSC was inundated with the challenges encountered by its serving and retired staff. This was visible in staff complaints and inability to meet up with certain financial obligations which sometime culminated into financial embarrassment. To this end, the need arose for a welfare scheme that can alleviate this financial burden. Hence, the Post Service Scheme was initiated.

The FRSC Post Service Scheme was therefore approved by the management of FRSC in March 2014 and subsequently implemented on 2^{nd} October, 2014 by the Corps Marshal Dr. BO Oyeyemi to serve as a welfare scheme for officers and men of the Corps.

ACHIEVEMENTS

Looking at the past, the present, for a better future, the Post Service Scheme is a kind of renaissance into a vital aspect of FRSC Staff welfare, hence, the Scheme has recorded the following achievements so far:

- Acquisition of 100 plots of land for staff in Kaduna, Kaduna State in October, 2016.
- Purchase of 10 flats for staff at Mararaba, Nasarawa State in April, 2016.
- Purchase of 52 flats for staff at Karulape, Nasarawa State in November, 2016.
- Provision of 1st and 2nd tranche auto revolving loan to staff through the FRSC Mega Cooperative in 2016 and 2018 respectively.
- Acquisition of 150 plots of land for staff in Kano, Kano State in August and December, 2017.
- Acquisition of 100 plots of land in Katsina in August, 2018
- Acquisition of 100 plots of land in Gusau Zamfara state in November, 2018
- Provision of equity to staff (RMA's) for acquisition of houses in Luvu,
 Nassarawa state.
- Developed a functional portal to facilitate staff real time on-line interface via pss.frsc.gov.ng where Staff can easily assess their account summary.
- · Sensitization lecture at RS7HQ.

PROCEDURES FOR PAYMENT OF DISENGAGED AND DECEASED STAFF'S BENEFITS

- Notification of retirement, termination resignation and death of a staff to PSS by CS/AHR.
- Removal of name from payroll by IPPIS
- CM's approval of clearance/Audit verified list of disengaged/deceased staff.
- Payment of contribution and interest to staff and deceased NOK's accounts.
- As staff retires or disengages from service, the PSS strives to pay them their PSS benefits within thirty days after the removal of their names from FRSC payroll.
