The above references conveyed the schedule for the FMB sittings in four (4) centres, Enugu, Kaduna, Ibadan and Jos between 31<sup>st</sup> July and 24<sup>th</sup> Aug, 2019.

- 2. The Jos and Enugu centres held in August and October, 2019 respectively. Due to circumstances beyond the Board's control, the Kaduna and Ibadan sitting could not hold as scheduled.
- 3. In order to conclude the sittings in remaining two (2) centres of last year, the Corps Marshal directed that the exercise should be held in Kaduna and Ibadan.
- 4. Consequently, the Board shall resume its sittings to:
- (a) Examine fresh reported cases of serious health challenges amongst staff.
- (b) Review cases of those who appeared before it at the previous times and were directed to seek further medical evaluation.
- (c) Staff who failed to appear in Jos or Enugu centre but now wants to appear in Kaduna or Ibadan centre.
- (d) Any recent case(s) that Commanding Officer(s) deem serious enough but was not reported before this sitting.
- 5. Any staff appearing before the Medical Board must come with recent medical report from his/her approved health care provider. In case of bone related cases, only recent x-ray with medical report is acceptable. For review, all those given specific directives must show enough evidence of compliance.

ZMOs are also to ensure that each affected staff comes to the Board with a recent medical report from his/her approved Health Care Provider including recent x-ray where applicable.

The ZMO In-charge of the centre where the FMB will sit is responsible for sourcing the external Medical Consultants (Specialists) one in Orthopedics and the other in Family Medicine/General Consultant Physician for that Centre. ZMOs are to note that the roles of External Medical Consultants are critical to the success and integrity of the whole exercise. The Consultants must be persons of high pedigree in Medical Practice, preferable from Teaching University Hospitals.

In case of bedridden staff, Commanding Officer of such staff is to take it upon himself to ensure that the personnel is informed of his/her invitation to face medical Board venue, date and time.

Commanding Officers are to direct emerging serious cases of ill health to the Board at the appropriate venue.

Note that Management has graciously given those who failed to appear at 11. Jos or Enugu sitting in 2019 opportunity to appear either at RS1HQ Kaduna or

RS11.3 Oyo State on the dates in paragraph 6(a) or (b). Staff who fails to utilize this grace should blame him or herself.
