REQUEST FOR SUPPORTING DOCUMENTS FOR PROCESSING OF GROUP PERSONAL ACCIDENT (GPA) INSURANCE CLAIMS FOR 2020 INSURANCE YEAR (BEGINNING FROM JAN TO DEC 2020)

Group Personal Accident (GPA) is a form of welfare package arrangement for all regular staff and special marshals designed to take care of medical bill incurred as a result of injuries that occurred from RTC and domestic accident.

- 2. Management consideration for staff welfare pays premium for Group Personal Accident (GPA) Insurance cover as a priority every year in order to see that the Staff involved in RTC and domestic accident are taken care of by the Corps.
- 3. We hereby request Commanding Officers to forward supporting documents of staff whose names appeared in the attached list for year 2020 Group Personal Accident claims.
- 4. The claimants are to forward the following original supporting documents:
 - i. Completed Employer's Liability Claim Form from (Linkage Assurance Plc.)
 - ii. Filled FRSC Insurance Notification Form
 - iii. Original Doctors Report (stating the date of injury and date discharged)
 - iv. Doctor's Prescriptions
 - V. Original Excuse Duty Certificate from Hospital or discharged certificate from hospital
 - vi. Original Medical Bills/Receipts received from Hospitals and Pharmacy Shops
 - vii. Police Report
 - viii. Certificate of Medical cause of death (if RTC lead to death)
 - ix. Three months Pay slips preceding the month of accident
 - x. Staff Identification Card (Photocopy)
 - xi. Photograph of the affected part of the body
- 5. The documents are to be forwarded immediately in order to speed up the process and to ensure prompt payment accordingly. Note failure to document these

claims within the period may result to the forfeiture of the claim to Underwriters as the claims for 2020 insurance year is about to terminate.

6. The affected staffs on the attached list are requested to forward their supporting documents in duplicate to DCM (AHR) RSHQ, while soft copy to the following email addresses: p.insurance@frsc.gov.ng, pand.insurance@frsc.gov.ng ahr@frsc.gov.nq on or before 1 February, 2021.
