- 2. The Ag. Corps Marshal has approved the sittings of FRSC Medical Board at Benin centre for the fourth quarter 2022 to review previous medical cases and evaluate new medical cases.
- 3. Any staff appearing before the Medical Board at the centre MUST come with the recent medical report from his/her approved health care provider. For bone related cases, recent X-ray of not more than six (6) weeks to the date of sitting must accompany the medical report. All those given specific directives must all show evidence of compliance.
- 4. Please note that any staff shortlisted but failed to appear before the Board shall be sanctioned appropriately and have his/her salary stopped forthwith.
- 5. In case there are emerging serious healthy challenges that were not reported before the publication of this Administrative Instruction, Commanding Officers are free to send any serious case to the centre with a covering letter to the Chairman of FMB attention the ZMO in charge of the centre.

DUTIES OF THE ZONAL MEDICAL OFFICERS

7. The Zonal Medical Officer (ZMO) in-charge of RS5.0 Zonal Clinics shall:

- i. Source for two (2) external Medical Consultants, one (1) in Orthopedics and the other in Family Medicine.
- ii. Clerk all the staff invited to appear before Medical Board under his jurisdiction.
- iii. Send soft copies of all the clerked staff to <u>di.okuobeya@frsc.gov.ng</u> one (1) week before the date of the Board sitting in his centre.
- iv. Ensure that attendance of all invited staff are taken and submitted to Secretary, Medical Board during the sitting.

SECURITY

8. The Zonal/Sector Intelligence Officer shall ensure the security/safety of the staff at the venue of the Medical Board sitting while the Zonal Provost shall ensure orderliness at the venue.

DUTIES OF ZONAL COUNSELLING OFFICER.

9. The Zonal Counsellor must be on ground to counsel any staff referred to him and present the report of all staff counseled to the Medical Board daily during the period of the sitting.
