# REQUEST FOR SUBSTANTIATING DOCUMENTS FOR PROCESSING OF GROUP PERSONAL ACCIDENT (GPA) INSURANCE CLAIMS FROM 2023 TO 2024 INSURANCE YEAR

Group Personal Accident (GPA) is an insurance package arrangement for all regular staff and Special Marshals designed to take care of medical bill incurred as a result of injuries sustained from official duty, unofficial and any form of domestic accident.

- 2. Management consideration for staff welfare pays Premium for Group Personal Accident (GPA) Insurance cover as a priority every year in order to see that the Staff involved in RTC and domestic accident are taken care of by the Corps.
- 3. Commanding Officers should forward substantiate documents of staff whose names appeared in the attached schedule from year 2023 and 2024 Group Personal Accident claims.
- 4. The claimants are to forward the following original supporting documents by scanning on PDF:
  - I. Completed Employer's Liability Claim Form from (Linkage Assurance Plc.)
- II. Duly Completed FRSC Insurance Notification Form
- III. Original Doctors Report (with brief medical history of the injury suffered stating the date of injury and fitness date to resume duty)
- IV. Doctor's Prescriptions (if any)
- V. Either original Excuse Duty Certificate from Hospital, discharged certificate from hospital or FRSC Excuse from Duty Certificate.
- VI. Original Medical Bills/Receipts or invoices received from Hospitals and Pharmacy Shops.
- VII. Police Report if available for injury (Not mandatory for injury)
- VIII. Police Report if accident lead to death (Mandatory for death case)
  - IX. Certificate of Medical cause of death (if RTC lead to death and is mandatory)
  - X. Three month Pay slips preceding the month of accident (Mandatory)
  - XI. Staff Identification Card (Mandatory)
- XII. Photograph of the affected part of the body
- 5. The documents are to be forwarded immediately in order to speed up the process and to ensure prompt payment accordingly. Note, staff who's name appear on the GPA schedule for 2023 and 2024 who failed to forward aforementioned documents on para 4 (I-XII) on or before 15<sup>th</sup> October, 2024 may result to the forfeiture of the claim to Underwriters as Corps had earlier endorsed the termination of the claims.
- 6. Staffs on the attached list are requested to forward their supporting documents through their commanding officer covering letter to DCM (AHR) RSHQ, while mailing the

## PROCEDURES FOR REPORTING GROUP PERSONAL ACCIDENT (GPA) INSURANCE CLAIMS IN FRSC

The claim processes for Group Personal Accident policy for a staff who involved in any RTC and domestic accident, are outlined below.

Notify the insurance unit of FRSC by calling or sending FIR through Zonal (AHR), text message on the following numbers: 08151790498, 09139600090 and emai: p.insurance@frsc.gov.ng copy pensionandinsurancefrsc@gmail.com and bm.bello@frcs.gov.ng. More often, the commanding officer is expected to do this on behalf of the staff (victim).

However the following documents are needed for Group Personal Accident claim:

### SUPPORTING DOCUMENTS NEEDED FOR GROUP PERSONAL ACCIDENT DOCUMENTATION

- a. Filled Linkage Assurance Plc Employer's Liability Claim Form
- b. Filled FRSC Insurance Notification Form
- c. Original Doctors Report (stating the date of injury and date discharged)
- d. Doctor's Prescription
- e. Original Excuse Duty Certificate from Hospital or discharged certificate from hospital
- f. Original Medical Bills/Receipts received from Hospitals and Pharmacy Shops
- g. Police Report (for RTC that lead to death)
- h. Certificate of Medical cause of death (if RTC lead to death)
- i. Three month Pay slips preceding the month of accident
- j. Staff Identification Card (Photocopy)
- k. Photograph of the affected part of the body

In case of RTC/Domestic Accident lead to death, the following documents are needed:

- i. Filled Linkage Assurance Plc Employer's Liability Claim Form
- ii. Filled FRSC Insurance Notification Form
- iii. Police Report (for RTC that lead to death)
- iv. Certificate of Medical cause of death (if RTC lead to death)
- v. Three month Pay slips preceding the month of accident
- vi. Staff Identification Card (Photocopy)
- vii. Pictorial Evidence
